

Ownership Structure

Analysis Uncover hidden risks with detailed ownership screening that maps complex vessel ownership structures across 7 levels of ownership relationships.

Voyage Risk Detection

High Risk Port Call Detection Identify and assess vessels calling at high-risk or sanctioned ports with automated, continuous monitoring that reduces regulatory exposure.

High Risk STS Transfer Detect potentially illicit ship-to-ship transfers in high-risk zones that reveal hidden sanctions evasion techniques or suspicious cargo movements.

AIS Spoofing Detection Stay alerted to vessels that transmit false AIS data to conceal their real location

Enhanced AIS Gap Detection Monitor vessel activity even during AIS transmission gaps that detects dark port calls and suspicious STS transfers when vessels attempt to operate undetected.

Abnormal Movements & Loitering Detect vessels behaving in an abnormal way, including potential illicit activity


